Renovations Begin On New Main Campus

The consumers and staff of The Arc of Jefferson County are one step closer to moving into the organization's new main campus. Renovations have started on the building, located off Crestwood Boulevard.

A new roof is in place, and new plumbing and fixtures are 75 percent complete. The move is something to look forward to for so many associated with The Arc.

"The staff is excited about the building," says CEO Chris Stewart. "It's because we've outgrown our current facilities. It's a dream come true."

The Arc's main campus is currently located off Green Springs Highway. It has been the organization's "home" for more than five decades.

While the building has been added on to and has served the Arc well, Stewart says it was time to find another place. Managers at The Arc quickly found the vacated Salvation Army Youth Detention Center and plans for renovations began.

Painting of the more than thirty rooms, kitchen, chapel and others areas started the last week of January and should last a few weeks. Next is new flooring and then wiring the building for computers and phones.

As renovations have begun, community supporters are hearing about The Arc's future move and making donations to help. For example, a local insurance company merged with another and had some extra furniture. These cubicles, desks and filing racks from USI will all come in handy at the new campus.

Moving day is not too far away. Stewart estimates administrative staff will be in the new campus by late March or early April, and the building will fully be serving consumers in July.

It's welcome news to staff like Derek Bond. The Associate Director of Day and Work Programs is hopeful about what it all could mean to the people The Arc serves.

"The move to the Crestwood building will provide consumers and staff with increased opportunities for recreation and training," says Bond. "Having access to a full functioning gym, several kitchens, and numerous classrooms presents The Arc of Jefferson County with a unique opportunity to improve on the overall day programming experience."

According to The Arc of

Health. It's the highest level of certification an organization can earn in the review process.

Jefferson County Associate Director Nancy Cook, the way the state reviewed agencies serving those with disabilities changed this In previous past year. years, the Arc's certification process took place at the facility level, meaning each residential home or day activity program center was certified and received their own individual score. This year, the Department of Mental Health looked at The Arc overall.

"This year's certification included new standards and a different process than what we've experienced," says Cook.

The state looked at thirteen different factors and sent representatives on site visits to evaluate The Arc on each one of them. To earn the twoyear certification, The Arc scored 100 percent on three of them, including safety, best possible health and protection from abuse and neglect. In the remaining factors like staff resources and rights protection, The Arc scored 90 percent or more.

"This new certification process is more focused on the individuals served and their responses and the information they provide regarding the services they receive," says Cook. "We are conducting more indepth interviews with individuals we serve. We want to make sure they are experiencing the things they want to experience through the services we provide."

The Alabama Department

The Arc Earns Two Year Certification

of Mental Health reviews service providers across the state to monitor the programs provided to people with intellectual and developmental disabilities. A provider needs the certification to literally stay in business, and also receive state and federal funding.

"It's exciting to get the two years across the board," says Cook. "We will continue to work on a reas that need improvement, and based on the review, we feel we are moving in the right direction."

"These dinners give us the opportunity for feedback with those we don't see on a regular basis," says Stewart.

Beginning in the Spring of 2014, membership gatherings will be held during lunch time in lieu of a regularly scheduled board meeting.

RecyclABILITY and its NAID AAA Certification

The Arc of Jefferson County's RecyclABILITY program has once again received the AAA certification by the National Association for Information Destruction (NAID), a differentiating certification that only a few of the businesses in the field can claim. The RecyclABILITY program has been AAA certified since 2010.

The RecyclABILITY program attained the certification by submitting for critical review their policies and document destruction procedure manuals, employment records, promotional materials, logs and paperwork to verify that they meet the requirements.

Success Story: Royal Cup Coffee

Service with a smile is exactly what Gena Hyatt at Royal Cup Coffee received when she hired RecyclABILITY to shred some of the company's documents.

"The guys were so pleasant, respectful and excited about their job," says Hyatt.

RecyclABILITY is part of the employment services program at The Arc of Jefferson County. People with intellectual disabilities are employed to run the truck, which destructs documents on site for businesses and even homeown-

Hyatt with Royal Cup first interacted with The Arc during a tour she took for United Way of one of The Arc's campuses. Shortly after she got a call about the possibility of hiring RecyclABILITY.

"My experience could not have been better. From the beginning, setting up the appointment was so easy. The crew came out and did the hard job of carrying the boxes outside to the truck. I even enjoyed visiting with the workers while we waited for the truck to pack the paper down. It was all wonderful and easy, breezy!" says Hyatt.

After documents are destroyed with RecyclABILITY, the remnants are recycled. Customers can even ask for a certificate to show that those items were taken care of through the program.

Using RecyclABILITY also helps bring awareness to the benefits of integrating the workforce with people who have intellectual disabilities. Hyatt says hiring

RecyclABILITY has changed her perspective.

"I know there must be hundreds of local companies that employ disabled individuals," says Hyatt. "Since my encounter with The Arc and its RecyclABILITY program, I keep my eyes and ears open for any of these companies and the opportunity to work with them."

It's been said a woman's hair is her crown of glory. Back in November, Erin of the North Central unit of The Arc of Jefferson County sacrificed her own crown to give someone an invaluable gift. She grew her hair for months to have it donated to Locks of Love.

"I heard about Locks of Love while watching the news one day," says Erin. "I called my dad and he told me about children who need help and I wanted to donate my hair to them."

Locks of Love is a public non-profit organization that provides hairpieces to financially disadvantaged children in the United States and Canada suffering from long-term medical hair loss from any diagnosis. Most of the children helped by Locks of Love

have lost their hair due to a medical condition called alopecia areata, which has no known cause or cure.

When asked how much hair she donated, Erin simply states, "A lot!"

Locks of Love requires that a minimum of ten inches be given.

"Going from having that much hair to not much at all was weird," says Erin. "My head is lighter now."
