Job Title: Licensed Practical Nurse (LPN)	Job Code:

Job Duties:

- Perform skilled nursing functions:
 - o Catheterization (clean or sterile)
 - o Administration of injectable medications
 - Calculation of medication dosages other than measuring a prescribed amount of liquid medication or breaking a scored tablet
 - o Gastric tube feeding
 - o Invasive procedures
 - o Sterile procedures
 - o Receive verbal or telephone orders from a licensed prescriber
 - Wound Care
 - o Suctioning
- Check in medications monthly and as needed, ensuring accuracy in regard to physicians' orders; make accurate changes to Medication Administration Records as needed for medication administration
- Review records of people served (post hospital or clinic appointments); follow up to ensure physician orders are completed
 - Train staff on all precautionary measures related to assisting people served with communicable diseases
 - o Train staff or care providers on medical treatments as ordered by physicians
 - Visit agency homes to assess people served (post-hospital) and ensure physician orders are followed
 - O Serve as a liaison between health care professionals, people served, and their families
 - Perform Focal Assessments related to Post-ER and Post-Hospital discharge
- Maintain records
 - o Complete documentation regarding care provided
 - o Complete monthly Medicaid billing for skilled nursing services provided to people served
- Delegate tasks related to the delivery of prescribed medications to unlicensed staff; monitor as needed
 - o Serve as on-call nurse in the Nurse Delegation Program on a rotating basis with other MAS nurses
 - Obtain MAS Certification and maintain current status
- Check medications for community participants (people served)
- Prepare MARs (Medication Administration Records) for day/work programs
- Attend inservice training and meetings as needed
- Perform other duties as assigned



Knowledge, Skills and Abilities Required:

- Must be a Licensed Practical Nurse, Licensed by Alabama Board of Nursing
- Must have excellent written and verbal communication skill
- Must be well organized
- Must have reliable transportation and valid Alabama driver's license; must be insurable by the agency's insurance

Physical Requirements:

- Frequent standing, walking, hand dexterity, reaching with hands and arms, climbing or balancing, stooping; kneeling, crouching, crawling, and speaking and listening both near and long distances; Must have vision abilities that include close vision, distance vision, color vision and depth perception
- Occasional sitting
- Frequent lifting and/or moving more than 50 pounds
